## **TERMS OF AGREEMENT**

The entry for the ISSR Challenge 2008/2009 implies, beyond respect for the regulations, different commitments from the drivers and co-pilots.

The common goal is to enhance the image of the ISSR Challenge 2008 /2009.

The nonobservance of these commitments will expose the people concerned to different sanctions explained in detail below.

### **Reminder :**

Only an entry for a championship allows to be graded and to beneficiate from the specific grants.

The registration must be done by the ISSR SA company at the latest 21 days before the date of the challenge concerned. This entry is taken into account from the moment the registration fees are enclosed to the demand.

## **GOOD BEHAVIOUR CODE**

From his behaviour, the driver registered for the ISSR Challenge 2008/2009 will not be allowed in any case, whether it is through his behaviour or his sayings, to be prejudicial to the ISSR Challenge image, or the different representatives, or to the organizer of the concerned challenge.

According to this, the driver, or his employer, (represented by the Team manager) is the guarantor of the good behaviour of his whole team, present on the ground during the ISSR Challenge 2008/2009 duration.

They will report to the ISSR SA company of any event that could occur, prejudicial to the good behaviour code.

## **RECOGNITION**

The driver commits to scrupulously respect the current regulation. Any proven infraction will be severely punished.

## **RIGHTS ON THE DRIVER'S IMAGE**

- 1 / The driver gives permission to the ISSR SA company, to use his name and/or image, his commentaries, his successes, his titles, his results gained during the tests or during races in France or in the world, via all communication media.

- 2 / The driver gives also permission for his name to be used by the ISSR SA company with its own image, and for his voice, his name and image to be recorded, amplified and reproduced on films or any other medium.
- 3 / The driver authorizes the use, especially the production (entire or in parts) of the above documents, as long as the ISSR SA company finds it necessary, without any duration limit. The driver gives up any claims linked to the use of the named documents, especially of financial ones.

<b>CANCELLATION- FINANCIAL PENALTY</b>

The ISSR SA company, in its full rights, will be able to exclude the driver from the ISSR Challenge 2008/2009 in case of any serious lapse undermining the good image of the ISSR Challenge.

Besides, any lapse could be subjected to a financial penalty of a maximum of 1 000 euros per proven lapse, which the driver recognizes and accepts..
